Tadgedale Green Space
Turning Circle (by pumping station)

Following a report of an unfortunate accident to a young lady (6 years old) in early October efforts were made by the Information Shop and Parish Council to establish who is responsible for this area. The ground is leased to Severn Trent Water (STW) and they examined the site and although it is fit for their purpose they have agreed that the surface needs to be changed. Over the next few weeks STW will arrange the removal of the strip of the grasscrete blocks and create a path similar to the path next to the play equipment. This will also cover (top dress) and seed the rest of the blocks to create a grassed and pleasant area to walk on.

It will be necessary to close the pathway between the bridge and the existing path for a short while. However access, to the play equipment and the village will still be available via the bridge at the end of Sharpland.

Parish Council and their part in the Planning Process

A Parish Council is what is known as a "Statutory Consultee" which means that the Planning Authority (County Council or Borough Council) must forward to the relevant Parish Council any planning application within the parish all the plans and relevant applications, for consideration.

A time limit is placed on the local consultation time, usually within 3 weeks, and during that time a Parish Council may do anything it thinks necessary to ensure adequate reflection of its views.

A Parish Council may make any comments on any application, and under certain circumstances it may request an extension of time for the submission of its views.

As a Parish Council is not itself a Planning Authority, the best it can hope for is that its views are taken into consideration by the Authority's Planning Officer or its Planning Committee. Further, it may request (but not require) that its Borough or County Councillors "call in" any application (this means usually that's it is taken to the Planning Committee rather than being decided only Planning Officers). This "calling in", however, is at the discretion of the Borough or County Councillors and not mandatory.

Any Parishioner may of course inspect any application and make comments within the specified consultation period. This includes Parish Councillors who may in this regard act in addition to their function as Parish Councillors.

Most Parish Councils (including Loggerheads Parish Council) make comments on applications but it has to be remembered that ONLY comments which are relevant to Planning Policy themselves need to be considered by the Planning Authority. A Parish Council and Planning Authority should make available to the public any application.

Any comments made by any person or Statutory Consultee should be considered and weighed up by the Planning Authority and reported prior to any decision by Committee or Officers. However, both Planning Officers and Planning Committees have wide discretion and paramount to the process is the over-arching requirement to conform with local or national planning guidelines. The Planning Authority must consider whether its decision can be appealed, whether it wishes to defend its position and if so what the financial considerations might be.

If an application is refused, only the Applicant may appeal. If it is allowed the only recourse is by the Secretary of State who may "call in" and review the permission and refuse it or set additional conditions. If it is believed the law has been incorrectly applied, Judicial Review may be sought.

Essential to the whole process is constant vigilance by the Public and Parish Councils, to avoid permissions being given by default or being given in ignorance of specific local issues of which the Planning Authority may not be aware.
